Whereas, the American Recovery and Reinvestment Act of 2009 (AARA) was a law enacted by the 111th United States Congress and signed by President Barack Obama on February 17, 2009; and,

Whereas, one of the purposes of ARAA was to provide funds to invest in education; and,

Whereas, the funds were designated as Flowthrough Funds, received by the Genesee Intermediate School Districts and provided to local school districts; and,

Whereas, Clio Area Schools received funds and utilized them for the purchase of a school bus for the transportation of special needs students; and,

Whereas, the Clio Area School District no longer requires the bus for the transportation of special needs students; and

Whereas, the bus has not reached the end of its useful life, and;

Whereas, Federal Funding Rules require assets purchased with Flowthrough Funds be returned to the grant sub recipient, the Genesee Intermediate School District, if the assets have not reached the end of useful life;

Now, Therefore, Be It Resolved:

The Board of Education hereby returns the school bus purchased with ARRA Funds in 2009 to the Genesee Intermediate School District effective May 26, 2015.
