# 2072: RESOLUTION IN SUPPORT OF THE GENESEE CAREER & TECHNICAL EDUCATION EARLY MIDDLE COLLEGE

**WHEREAS**, the Genesee Intermediate School District (Genesee ISD) provides services to the local public school districts in Genesee County, including post-secondary opportunities;

**WHEREAS**, the Clio Area Schools Board of Education is committed to developing new, innovative approaches to teaching and learning in our existing and future schools.

**WHEREAS**, the Clio Area Schools Board of Education endorses the Genesee County CTE Early Middle College (EMC) Model for the local public school districts in Genesee County as a partnership between Baker College, Mott Community College and the University of Michigan-Flint, Genesee ISD and local school districts with the potential for expansion to include additional postsecondary partners.

The Genesee County CTE Early Middle College Model consists of:

- An early college "without walls" for Genesee County students.
- Early College application approval from the Michigan Department of Education.
- An application process during the 10<sup>th</sup> grade year of high school for admittance in 11<sup>th</sup> grade.
- 5-year graduation requirements for the EMC based on a CTE pre-approved program of study.
- A 13<sup>th</sup> year graduation requirement including the final year of math.
- Programming at any Genesee County local district high school, Genesee Career Institute (GCI),
   Carman-Ainsworth STEM EMC, Carman-Ainsworth Baker EMC, Davison High School EMC

- Program, Genesee Early College, Grand Blanc High School EMC Program, Clio Mott Scholars EMC, Mott Middle College High School, and postsecondary campuses.
- Attainment of a CTE associate's degree, industry certification, 60 transferable credits (towards a CTE degree) or Michigan Early Middle College Association Certificate (MEMCA) by the end of grade 13.

**WHEREAS**, the Clio Area Schools Board of Education endorses the Genesee County CTE Early Middle College Model for the students in Genesee County.

**THEREFORE, BE IT RESOLVED** that the Board of Education endorses the Genesee County CTE Early Middle College and recommends implementation as a best practice for eligible students in the Genesee County.
